1. List various communication strategies used in your school to provide additional information to parents and to increase parental involvement in supporting classroom instruction.

The Mountainburg Public Schools Parental Involvement Plan is developed with the help of faculty, staff, administrators, and parents. The Parental Involvement Plans are disseminated to the stakeholders through the Board Policies, including Licensed, Classified, Student, and School and Community. It is also available on the school website at www.mountainburg.org. The policies are available at the Parent Center, District Administration Building and website.

The PIP (Parent Involvement Plan) is reviewed annually in the spring with a Title I meeting to discuss successes and areas needing improvements. This meeting is held in the spring when results of the work being accomplished is near completion and can be evaluated by informal testing and Title I scores kept on our students. Jason Rutherford, High School Principal, is the facilitator of the annual Title I meeting. All stakeholders will be given the opportunity to make recommendations for changes. The PIP makes every effort to involve parents during the school year. At the beginning of the year, an open house is held for all parents and students. Parent Teacher Conferences are held twice a year.

During these conferences the PI Committees have an area set up to distribute materials to parents. The District conducts inservice in which the school reviews the ACSIP plan, which includes the Parent Involvement Plan. Trisha Shepherd is responsible for coordinating these parental involvement activities with other programs in the district, as well as being responsible for establishing a contact person at the Elementary School and the other campuses. This inservice day is used to implement any changes that need to be made for the spring Title I meeting, assessments, and needs of the community. Title I is also discussed at the Board Meeting in which the ACSIP plan is approved and discussed at the annual Report to the Public. The District makes available any assistance to parents with students with disabilities the ability to participate in any of the activities at school, including Parent Teacher Conferences, PIP committee activities, and any other events at the school. The school will send home report cards each nine weeks, and progress reports between each report card. The language of the PIP is such that all the parents can understand the meaning of the words and content. Parents are involved in the process of the review throughout the year with suggestions, at the Title I meeting, and at the ACSIP meeting. All parents are invited to attend the ACSIP inservice day, Open House and Parent Teacher Conferences. They are made aware of these opportunities through SchoolMessenger, the district Facebook page, and the district website calendar. Parents help to revise, update and improve the PIP so that children in our school fully prepared for the future.

2. Teachers will hold individual parent conferences with parents in their classrooms. During these conferences parents will be provided with student's grades, summary and explanation of students test scores, RTI information, and the interventions that are being used and the progress that is being made to assist the child in reaching achievement goals that have been set for the student. Parents will be encouraged to express how they will help and support their child in these efforts. The school will encourage parents to be involved in various activities and serve in various roles to increase parent involvement and support for student learning including book fair helper, Grandparents Day, field trip

volunteers, music program performances, open house, veterans day programs, etc.

During these conferences parents will be provided with student's grades, summary and explanation of students test scores, AIP and RTI information, and the interventions that are being used to assist the child in reaching achievement goals that have been set for the student.

Parents will be encouraged to express how they will help and support their child in these efforts. The school will encourage parents to be involved in various activities and serve in various roles to increase parent involvement and support for student learning including book fair helper, Grandparents Day, field trip volunteers, music program performances, senior scholarship night, FAFSA work night, grade-level sponsors, grade-level newsletters, district website, district Facebook page, district app available on SmartPhones and Androids, open house, various banquets, athletic department volunteers, and Veterans Day programs.
